


Ten Frequently Asked Questions (FAQs)
Edition #10 2024-25 School Year – Week of October 14, 2024
Questions are quoted as I received them directly from our community.

### 1. When can we count on Frontline ERP leave balances to be caught up? Nobody shows their vacation credit for this month nor has the leave taken in September been deducted.

All balances are available in both Frontline Absence Management system (formerly AESOP) and Employee Portal (ESCAPE). Absences and accruals are always a month behind. Once the month ends, Sites/Department complete the previous month's "absence reconciliation" by the first week of the next month. HR Operations then needs a couple of weeks to re-verify the data and enter it into ESCAPE. For September, reconciliation was completed on October 7th by sites. September usage and vacation accruals will be granted and posted before the October payroll runs (usually by the 20th of the month) which will then reflect in the employee portal and then into AESOP. #### 2. You sent out a survey regarding the name change for the Department of Public Safety. What was the result?

We received 242 survey responses, of which 81.8% agreed with the name change back to SUSD Police Department, 9.5% stated that they did not have a preference and 8.7% stated they did not agree with the name change. Due to the overwhelming support for the name change from both the survey and from responses at the Safety Townhall, the SUSD Board of Trustees approved their name change back to SUSD Police Department at the October 15, 2024 Board Meeting.



### 3. I see that you have these cameras at the entrance to all of the school sites now where people have to buzz in. Do those camera systems keep a recording of who enters into the building?

The access control cameras at the front gate of the school sites only provide a live interface for viewing; they do not have a recording feature.

### 4. At the Conversations with the Superintendent, you mentioned that each school site was going to have an Equity Team. What are the responsibilities of the Equity Team members?

Each school site will indeed have an Equity Team, and their responsibilities will be crucial in promoting and maintaining equitable practices across our district. Below is an overview of the key responsibilities of the Equity Team members:

- Data Gathering and Analysis: The team will collect and review school-wide data, including student achievement, disciplinary actions, and access to resources, all through an equity lens.
- Identifying Barriers: A significant part of the team's work will be to identify any barriers that might prevent students from having equitable access to educational opportunities.
- Creating Solutions: Once barriers are identified, the team will propose and implement strategies to address these challenges and promote equity within the school.
- Dissemination of Information: The team will share their findings and equity-related updates with all stakeholders, including staff, parents, and students, to ensure transparency and collaboration.
- Engagement and Feedback: They will also facilitate ongoing dialogue with the broader school community to gather feedback and monitor the progress of their initiatives.
- Monitor and Adjust: Lastly, the team will continuously monitor the effectiveness of
  equity initiatives and make adjustments as necessary to ensure their efforts are
  successful.

## 5. Hello Dr. Rodriguez, Yesterday, SUSD onward shirts were distributed to my school site. All office staff and teachers got a shirt. I was wondering where the shirts for the preschool assistants are?

I am glad to hear that the office staff and teachers at your site received their SUSD Onward shirts. I am sorry that you did not receive one. The shirts were made available to all staff members, but in order to receive one, everyone needed to fill out the request form. The information was shared in several of my weekly staff messages, and in the Ask Dr. Rodriguez FAQs I send out every Friday. Unfortunately, the deadline to request a shirt has passed, so we are not able to provide additional SUSD Onward shirts at this time. However, if we are able to secure another donor in the future, there may be another opportunity for staff to order shirts.

#### 6. Over the Fall Break, my site received new cameras. Will all sites receive them?

As part of our commitment to improve safety throughout the District, we have done an evaluation of camera coverage at all 55 sites. We are upgrading and increasing camera coverage in phases. Our first phase included 1262 new cameras at 15 sites as noted in the chart below. We are currently working through the procurement process to implement another set of sites for a second phase.

### 7. Can you provide me information on the new system that the Stockton Police Department (I know it is not us) are implementing for emergencies and evacuations?

The Stockton Police Department has launched a new program to better support individuals who live or work in Stockton. This initiative allows parents, guardians, or individuals to provide the department with essential information about any accommodations their loved ones may need in case of an emergency, such as an evacuation or a 911 call. By registering, you can help officers be prepared with the necessary accommodations before they arrive on the scene. This program is particularly beneficial for residents or employees who are deaf or hard of hearing, have mobility challenges, or are sensitive to loud noises or bright lights.
