SUBJECT: **Professional Development – Mandatory Training**

Dear SUSD Campus Safety Staff,

We are excited to announce our upcoming Professional Development Training Days scheduled for July 24 through 30 from 8:00 am-4:30 pm. During this time, you will be assigned to one or more of the following sessions: SB 390 Certification, CPI (Crisis Prevention Institute), Emergency Preparedness & Response, or Breakout Sessions.

SB 390 Certification

This course is mandatory under state law for all campus safety personnel assigned to work on school campuses. Even if you have previously completed SB 1626, attendance at this course is still required.

Participants must attend three full days to receive certification. This course ensures full compliance with state regulations and prepares you for your critical role in maintaining campus safety.

CPI (Crisis Prevention Institute) Training

CPI training is essential for equipping campus safety staff with effective de-escalation strategies and nonviolent crisis intervention techniques. It is widely used in education, healthcare, and security sectors. This is a district and DOJ required course.

For those assigned to CPI course, your attendance to both days is required for certification.

Emergency Preparedness & Response

This is a one day, scenario-based training course focused on emergency response skills. Through practical exercises, staff will learn how to effectively respond to various emergencies that may occur on campus.

- Training assignments and locations will be provided to each participant via letter, email, and through the Kick-Up app. The course roster is posted on the district's website.

- Please bring a water bottle or beverage, as hydration is important and drinks may not be provided on site.
- Employees will be required to sign in and out using the attendance sheet provided to ensure accurate tracking of arrival and departure times.
- If you are an 8-hour employee and arrive late, you will need to record any missed time in Frontline.
- If you are a part-time or less than 8-hour employee, additional time will be time sheeted. Any missed time will be adjusted accordingly.
- If you are a 4–6 hour employee, overtime is approved and you will be time-sheeted for the training.

We strongly encourage the completion of the assigned classes. Failure to do so will result in a make-up class that will start from the beginning until fully completed in one session.
