

**Side Letter Agreement (SLA)
Between
Stockton Unified School District (District)
And
Stockton Unified Supervisory Unit (SUSU)**

April 18, 2024


This agreement concludes 2023-2024 negotiations between Stockton Unified School District (SUSD) and the Stockton Unified Supervisory Unit ("SUSU"). The parties hereby agree to the following terms subject to the ratification of the Stockton Unified Supervisory Unit ("SUSU") and the Board of Education for Stockton Unified School District. All remaining provision in the current collective bargaining agreement shall remain unchanged and said negotiations will be deemed concluded for 2023-2024 with reopeners for the 2024-2025 school year.

Both parties have agreed to the negotiated components included herein:


- Effective July 1, 2022: 2%*
- Effective July 1, 2023: 4% plus an additional one-time lump sum payment of \$5,000.
*The retroactive payment from July 1, 2022 through June 30, 2023 will be applied to base salary only. No retroactive payment will be made on timesheets, stipends, substitute timesheets, extra duty, or any extra compensation aside from base salary for July 1, 2022 through June 30, 2023. Effective July, 2023, the 2% applies to all compensation.
- If any other SUSD bargaining unit receives a total increase to their salary schedules greater than 6% combined for 2022-2023 and 2023-2024, the SUSU salary schedules shall be increased by the same percentage. If any other SUSD bargaining unit receives a total lump sum payment greater than \$5,000 for 2023-2024, SUSU and SUSD will immediately meet and confer over additional lump sum payments for the SUSU bargaining unit.

This agreement shall be effective upon ratification by both SUSU and the Stockton Unified School District Board of Trustees and shall continue in effect through June 30, 2025.






