6.1 ParentVue Presentation - Poaze Lee and Team, Technology & Innovation Services

- Any parent/guardian with educational rights to a student can create a ParentVue account
- ParentVue is for currently enrolled students
- ParentVue eliminates the need to complete the large packet of paper forms we have typically been given every year
- Parents will be able to view attendance, assessments and other student data in one place
- Parents can create an account by either downloading the app or going onto the webpage. The steps are slightly different depending on the device. Follow the steps. Check your email for the Activation link and then create a username and password
 - You will then enter your family information

- Enter Emergency Contact information
- Student Enrollment information
- Required Documents
- Review & submit
- Dr. Rodriguez
 - The District is trying to become more efficient and improve communication

- Benefits of involvement
 - Child development - emotional social and cognitive
 - Better academic performance and improved problem solving skills
 - Improved vocabulary and communication skills
 - Promotes curiosity
 - Emotional resilience, expressing emotions in healthy ways
 - Academic success - higher grades and school readiness
 - Behavior - positive behavior and reduced behavior issues
 - Health - better physical and mental health outcomes
- Long term - higher education, healthy relationships, confidence, achievement motivation
 - Greater likelihood of pursuing higher education
 - Teaches empathy and communication skills and maintaining meaningful relationships
 - Confidence into adulthood
 - Greater ambitions
- Involved parenting can perpetuate positive cycles where children grow up to become attentive parents themselves passing on the benefits of engagement, and nurturing to the next generation
- Barriers
 - Balancing work and family
 - Lack of resources
 - culture/language barrier
 - Educational background - parents may lack formal education
- Strategies
 - Communication - be open minded
 - Support programs - workshops, resources and support groups
 - Healthy boundaries w/in relationships - helps children understand expectations
 - Encouraging home learning - learning activities that can be done at home
