Athletic Contract

1. To be eligible for any team, the student must meet CIF, SUSD and Edison High School eligibility requirements. SUSD and the State of California require a Grade Point Average (GPA) of 2.00 and the student athlete must maintain credits towards graduation. Eligibility will be checked each semester.
2. All athletes must pass a physical examination and have it uploaded into FamilyID. The athlete and parents must sign the emergency information and the player packet signature form. This form needs to be submitted to FamilyID before the student is allowed to compete.
3. An athlete may change from one sport to another only if he/she has permission from both coaches. An athlete is not allowed to quit a sport from one season to go out for another sport the next season. The athlete MUST finish the sport from the previous season.
4. An athlete MUST be in school a minimum of 2 classes in order to participate in a game or practice held on that day. A legal admit must be presented if the athlete misses any part of school on a game or practice day in order to be considered for participation.
5. An athlete MUST attend practices in order to play in the games. It is up to the coach and the individual sports program to determine the discipline for missed practices (see program guidelines)
6. A student athlete will immediately become ineligible and could lose all playing privileges for that season of sport for any of the following reasons:
 - A. Quitting a sport without a justifiable reason or consent of the coach.
 - B. Smoking, drinking, and/or the use of illegal drugs.
 - C. Acting in a manner that may bring dishonor or shame to the community or school.
 - D. Fighting or coming off the bench or sideline during any fight on the playing area.
 - E. Consistent discipline, academic and/or attendance issues.
 - F. Participation in a non-school sponsored team, such as city league, shall make the athlete ineligible for a school team of that same sport if the participation is during the season.

****Eligibility may be earned back at the discretion of administration and / or the coach**

7. Student-Athletes are representatives of EHS and at all times must conduct themselves in a manner that reflects positively on their teams, school and community

Failure to comply with any of the requirements stated in this contract will be referred to the Coach, the Director of Athletics and/or the Administration for appropriate discipline outlined in our code violations.

Code Violations and Team Disciplinary Action:

1. Smoking/Distribution/Sale or Use of Tobacco Products - First Violation: Ten (10) day suspension from all scrimmages and contests . A suspended player is required to participate in all practices. Second Violation: Twenty (20) day suspension from all scrimmages and contests. Third Violation: Will result in forfeiture of eligibility to participate in athletics for one (1) year from the point of infraction.

2. Smoking/Distribution/Sale or Use of Marijuana or Marijuana Products - First Violation: Ten (10) day suspension from all scrimmages and contests . A suspended player is required to participate in all practices. Second Violation: Twenty (20) day suspension from all scrimmages and contests. Third Violation: Will result in forfeiture of eligibility to participate in athletics for one (1) year from the point of infraction.

3. Possession of and/or Consumption of Alcohol and Over the Counter Performance Enhancing Products. First Violation: Ten (10) day suspension from all scrimmages and contests. A suspended player is required to participate in all practices. Second Violation: Twenty (20) day suspension from all scrimmages and contests. Third Violation: Will result in forfeiture of eligibility to participate in athletics for one (1) year from the point of infraction.

4. Fighting- 45 day social probation(suspension interventions document)

5. Theft or Vandalism: to any school property (Home or Away) while under the supervision of a coach or while representing the school team in any way. First Violation: Ten (10) day suspension from all scrimmages and contests. A suspended player is required to participate in all practices. Second Violation: Twenty (20) day suspension from all scrimmages and contests. Third Violation: Will result in forfeiture of eligibility to participate in athletics for one (1) year from the point of infraction.

6. Conduct Unbecoming or Other Actions or Excessive Misbehavior: that would reflect negatively upon the team or school. First Violation: Ten (10) day suspension from all scrimmages and contests. A suspended player is required to participate in all practices. Second Violation: Twenty (20) day suspension from all scrimmages and contests. Third Violation: Will result in forfeiture of eligibility to participate in athletics for one (1) year from the point of infraction.(ex. Running to/instigating/recording or being present at a fight)

7. Cutting Class: If a student is found cutting a class more than once in a day, that student will be suspended from all activity that same day. That includes practices, as well as scrimmages, games, meets and matches. If the multiple cuts goes undetected until the next school day, then the suspension will take effect immediately for that school day

***NOTE: Suspensions will be carried over to the next season of participation**
