**5.0 District Guest Report.** Dr. Traci E. Miller. Good morning everyone, with these headphones that we are using we have all the United Nations; I want to recognize Dr. González that we have him via Zoom. Thank you all for being here. ## 7.0 Reports

**7.1 District Master Plan for English Learners.** Dr. Israel Gonzalez. We have the master plan for every 3 years, we are going to update it and I want to invite you to participate, we want suggestions and recommendations from parents to make this plan stronger. Our first meeting will be on October 17, 2022, at 9:15 am.

**7.2 LCAP Updates.** Dr. Israel Gonzalez. This plan is important because we talk about school climate, we have 4 goals:

Goal 1: Increase student achievement by providing first instruction.Goal 2: Promote equitable and healthy learning environments that enhance social learning.Goal 3: Create a culture of inclusion and collaboration with families and community stakeholders.Coal 4: Increase the enduction rate for students with disabilities and increase the learning of the statement of the statemen

**Goal 4:** Increase the graduation rate for students with disabilities and increase the learning rate for special education students.

I can write another goal for other types of students if they continue to have low grades, we can create it for another time.

Sandra Arreola asked a question based on goal #2. How are you going to deal with fights in schools because this is increasing every day?

Dr. Gonzalez answered: Good question. With the culture, the teachers and directors of the schools, combine them to see how to give more resources. PBIS is what this is for, behavioral intervention and how to improve culture, it's a combination.

Angeles Cortés commented that education begins at home and our teachers and directors must set the example and the toxic influence of directors and teachers must be abolished, we ask that you as district leaders be an example, be professionals, do not bring personal problems to the school and if there is a conflict or problem give it a solution and clean the slate, do not retaliate forever. Give solution and start again.

After the question and comment, Dr. Gonzalez showed the general budget on the distribution of funds, he showed the graphs on the distribution.

## 8.0 Old Business.

**8.1 Review and comment on the district's procedure for reclassification of English learners.** Maria Lazaro, Specialist in Instruction. Hello. We are going to do an activity because this helps to learn in a better way, and she explained what the activity would be like. Reclassification of English Learners to English Proficient. Reclassification criteria are established by the California State Department of Education. There are four reclassification criteria:

- 1st Criteria is the ELPAC Language Test, the level that students must have as a result is 4.
- 2nd Criteria, the next criteria for reclassification is the teacher.
- 3rd Criteria, the consultation or opinion of the parents.
- 4th Criteria, is a basic test that is i-Ready or the SBAC State Test, the score for SBAC is 3 or 4 for reclassification only.

At 10:50 am a motion was made to extend the meeting, the time was left open. First motion Rosa Arana. Second motion Catalina Ramos. Motion approved.

ELPAC evaluates the Listening, Speaking, Reading and Writing, for the Expression, the teacher has a rubric, where the teacher says if they are proficient or not proficient in English. Consultation with parents can be in person, by mail, or by phone.

K-8 there are 3 opportunities: 1st is in the fall. 2nd is in the winter. 3rd is in the spring. From 9-12 High school students have 2 opportunities in the first semester, at the beginning and at the end of the first semester. In the second semester, at the beginning of the semester and at the end of the semester. 2021-2022: 847 students were reclassified. 2022-2023: 177 eligible students at the first opportunity.
